3. The meeting concluded after vote of thanks.

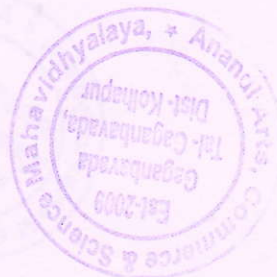
